

# "Diann Morris— A Woman of Principles and character"

Diann's husband decided to move on and they ultimately were divorced.

She then met a gentleman by the name of Robert D. "Bob" Morris. Diann and Bob were married and she was blessed with two more sons, Wade and Danny. In 1980 Bob was given the opportunity to work for ITT Aerospace in Burbank, California so the family moved to Thousand Oaks, California. In 1981 she found employment with Northrop Corporation in the Program Control department. While there she worked on two major defense programs, the F-18 program and the B-2 program in cost control and project management.

In 1990 Bob and a reluctant Diann started a small molding company by the name of RAM Inc.

#### Controller

RAM is pleased to announce the hiring of Nikki Lewis as our controller. Nikki has been with RAM for the past few months to transition the financial responsibilities from Ms. Morris who has retired. Nikki has over 15 years of experience as a Director, Controller, and Financial Analyst.

As a Director at FTS International, Nikki managed a department with 20 direct reports. She managed Accounts Payable for over 30K invoices per month and Payroll for 4,000 employees. She was responsible for the hiring and training of clerical and professional staff. She managed several major system conversions, business acquisitions and divesting of a major business segment.

Ms. Lewis also served as Controller for Miller Group of Companies located in Southlake, Texas. She managed the accounting departments for multiple companies, which included retail stores as well as a recycling company with gross sales of 10 million dollars. While there she was responsible for the hiring and training of the accounting and clerical staff. She produced monthly financial packages with variance analysis and GAAP compliance. She was also responsible for accurate inventory costing and movement of goods for the recycling company. She managed cash flow, established banking relationships and assisted in loan procurement. She coordinated external audits and PBC schedules.

Nikki also has significant experience as a Financial Analyst. She held that position with RTW

Financial Advisors of Dallas Texas. While at RTW she provided Financial and Investment Advisory Services. As a Financial Analysist her duties included general ledger, financial statements as well as investment reports for individuals and businesses. She provided coordination with external auditors and tax preparers to maximize tax benefits and control expenses. Nikki managed payroll taxes as well as insurance and leases. Her clients included real estate investors,, physicians, stock and bond investors and individuals.

Nikki's first assignment as a Controller was at Prodel Automation located in Coppel, Texas. Prodel Automation is a Robotics Manufacturer specializing in assembly line operations. She was in the United States accounting operations which used both SAP and Peachtree accounting software. She managed payroll, employee benefits, auto leases and inter-company transactions. She was responsible for completing monthly inventory costing, entries for WIP, and finished goods and accounts receivable. As Controller she prepared financial reports and presented them to the CEO.
